

## Annual General Meeting of INFICON Holding AG of April 12, 2018

Out of a total of 2,416,078 registered shares at a nominal value of CHF 5.00, 1,132,762 registered shares were represented. 124 shareholders and shareholders' representatives were present. The independent proxy holder represented 831,141 shares. In all, CHF 5,663,810 of the share capital or 46.88 % of the entire capital of CHF 12,080,390 were present or represented.
