

## Annual General Meeting of INFICON Holding AG of April 29, 2015

Out of a total of 2'343'586 registered shares at a nominal value of CHF 5.00, 1'591'580 registered shares were represented. 83 shareholders and shareholders' representatives were present. The independent proxy holder represented 1'509'788 shares. In all, CHF 7'957'900 of the share capital or 67.91 % of the entire capital of CHF 11'717'930.00 were present or represented.
